VENDOR/EXHIBITOR RULES, REGULATIONS, TERMS & CONDITIONS

- Vendors must provide a sample photograph and/or link to a web site representing the items/services they intend to sell/promote.
- Vendor slots will be assigned by a representative of Space Coast Motor Officers Inc.
- Vendor fees are non-refundable
- A Vendor slot consists of one 10' X 10' space. Each vendor is responsible for bringing and providing any other necessary equipment and supplies to do business at the event. Space Coast Motor Officers Inc. does not loan, rent, or in any way supply vendors with additional equipment.
- Vendors must provide their own table covering. All tables **MUST** be covered and look professional.
- All Vendors must provide their own signage. All signage must look professional and identify the vendors name/company. Signage must remain in their own 10' X 10' vendor space.
- All Vendor activities must be confined to allotted space.
- The consumption of alcohol on premises by vendors is not allowed.
- Each Vendor is responsible for his/her booth and all items in it.
- Booths must be ready to open by event start time and remain open until the conclusion of the event.
- Vendors must comply with the rules & regulations of Space Coast Motor Officers Inc., the event venue location and, The City of which the event is being held, Brevard County, and the State of Florida.
- Rules may be subject to change without advance notice.
- Space Coast Motor Officers Inc. reserves the right to assign, limit the quantity of, or relocate space(s) rented by a vendor. The sharing or subletting of booths is not permitted.
- If food sales are part of booth, Vendor must pass state health inspection and provide any fees the state health inspector may levy.
